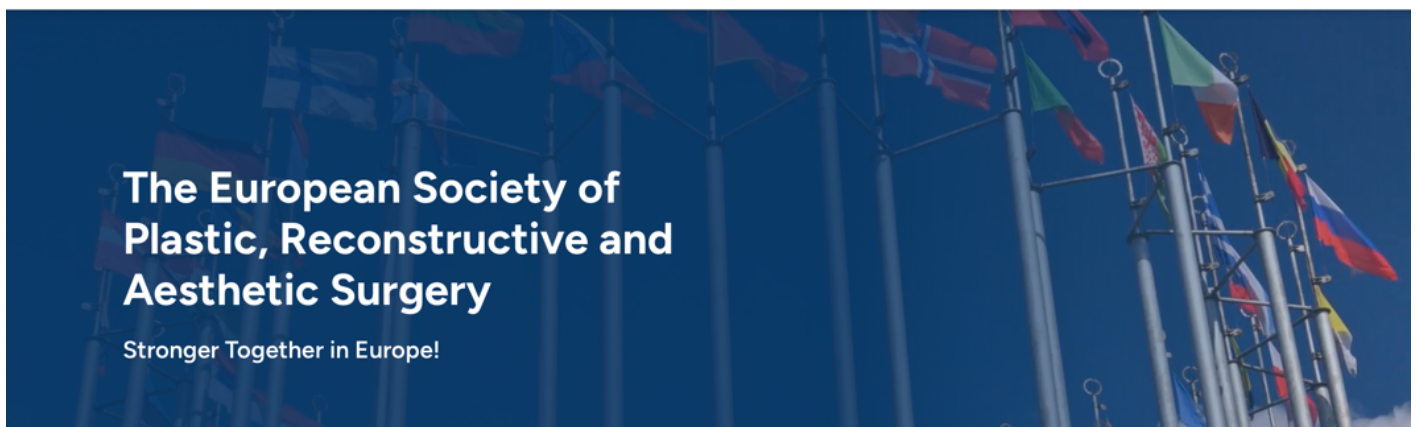
In the members section, forms are available for members to confirm and update their society's information with information for both the congress calendar and dissemination via social media, and also to enable them to submit information regarding minifellowships.

# ESPRAS Council of Delegates Meeting in Paris, November 23<sup>rd</sup> 2024

*ESPRAS Board of Directors*

During the next ESPRAS endorsed national meeting in Paris “ESPRAS – A day in Paris” on November 22<sup>nd</sup> an ESPRAS Council of Delegates meeting will take place on Saturday, November 23<sup>rd</sup> 2024. All delegates of national member societies of ESPRAS are expected to participate. The Council of Delegates is the decision making body of ESPRAS.

There will be a proposal to update the statutes both to secure continuous renewal of the ESPRAS ExCo with new active members and to secure continuity and to make the ESPRAS ExCo more effective in developing ESPRAS to the benefit of all. Proposals for the update of statutes will be notified at least six weeks before the meeting.

It is anticipated that there will be a requirement to vote for new ExCo Members in the five regions of ESPRAS (see ESPRAS statutes):

- **North:** one delegate, five countries
- **West:** three delegates, six countries

- **South West:** two delegates, four countries
- **Central and East:** two delegates, ten countries
- **South East:** two delegates, fifteen countries

The ESPRAS Council of Delegates is composed of one delegate from each of the affiliated National Societies. The delegates were nominated for ESPRAS quadrennial Congress in Porto, Portugal 2022 by the respective National Societies for tenure of four years renewable once. The delegate is the spokesperson for the National Society to ESPRAS and vice versa. If a national society is represented in the ExCo it shall nominate another member as its delegate to the Council. All ExCo officers are full members of the Council of Delegates with voting rights. If a delegate is unable to attend the meeting in Paris, the delegate may transfer the right to vote to another person who has been designated by the national society, with the consent of the non attending delegate.

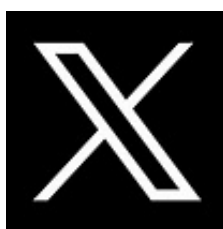

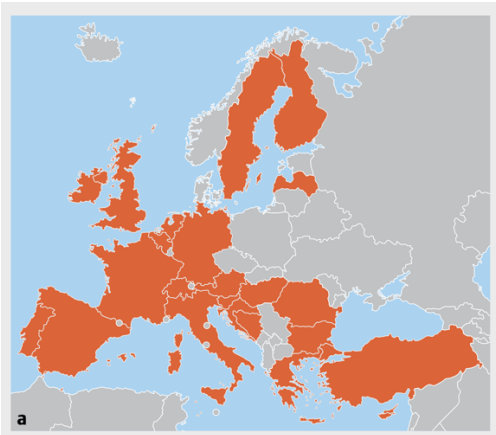

# ESPRAS Survey on National and European Societies in Plastic Surgery now published!

*ESPRAS Executive Committee (ExCo), Switzerland*

The European Society for Plastic, Reconstructive and Aesthetic Surgery (ESPRAS) has published its latest survey on National and European Societies in Plastic Surgery. The purpose was to identify synergies and redundancies and promote improved cooperation and exchange to enhance coordinated decision-making at the European level.



The ESPRAS survey included 22 national and 9 European Plastic Surgery societies representing more than 7000 Plastic Surgeons in Europe. Most national societies consist of less than 500 full members. European societies, which

covered the full spectrum or subspecialties, differed in membership types and congress cycles, with some requiring applications by individuals and others including national societies. The main purposes of the societies include research, representation against other disciplines, specialisation and education as well as more individual goals like patient care and policy regulation.

This ESPRAS survey offers key insights into the structures, requirements and challenges of national and European societies for Plastic Surgeons, highlighting the relevance of ongoing close exchange between the societies to foster professional advancement and reduce redundancies. Future efforts will continue to further explore strategies for enhancing collaboration and harmonisation within the European Plastic Surgery landscape.

# The ESPRAS study on European Quality Indicators for Breast Reconstructions needs engagement from all national delegates and societies. Please enroll your experts and patient representatives!

In March 2023 at the ELF meeting in Munich it was decided to start a study based on consensus from professionals *as well as patient organizations*. By including patient opinions' we believe that the indicators will have more impact on the quality of breast reconstruction through Europe and thus improving the quality of life of all the women in Europe undergoing breast cancer therapy. The inclusion of patient organizations could also increase the impact of the quality indicators on policy making political organizations such as the European Parliament, that have previously adopted the EUSOMA guidelines. Moreover, quality indicators made by patients, plastic surgeons, and nurses have the potential to be used as a foundation for funding applications of study protocols related to patient related outcomes, quality and safety in breast reconstruction. Therefore, the creation of relevant quality indicators by our ESPRAS

community's experts in breast reconstructions in cooperation with patients have the potential to affect an enormous number of women and plastic surgeons.

As the European Commission published in 2020, the breast cancer burden in EU-27 countries is high, with an estimated incidence of 355,457 new cases and 91,826 deaths a year. While breast cancer is curable in 70–80% of patients with early-stage, non-metastatic disease, locoregional and systemic therapy approaches often leave women physically and psychologically impaired. Breast reconstruction has become an invaluable part of recovery for many women and plays a central role in holistic breast cancer therapy, increasing patients' quality of life. Nonetheless, the field of breast reconstruction is confronted with several controversially debated topics, requiring harmonization on an international level,

why clear evidence-based guidelines are urgently needed.

So far, the only European standards for breast reconstructions are described by EUSOMA. And since the European Societies in Plastic Surgery did not participate in this project the outcome regarding standards and quality indicators does not mirror the plastic surgery perspective.

This ESPRAS study is based on a consensus principle – a Delphi procedure, where European plastic surgeons and nurses with expertise in breast reconstructions and patient representatives from all European countries will be participating. The participants will answer a three stage questionnaire on-line (distributed by Google Forms, Google, California, U.S.).

The study is coordinated by Emma Hansson from Gothenburg, Sweden and Nicholas Moellhoff from Munich, Germany. ESPRAS

ExCo representative is Anna Elander. Delegates representing ESPRAS Council of Delegates are Rado Zic, Lisbeth Hölmrich, Ilkka Kaartinen, Ruth Waters, Nicolas Möllhoff, Emma Hansson, Anna Elander, Riccardo Giunta.

# ESPRAS Survey on Tranexamid Acid (TXA) in Plastic Surgery

Tranexamid Acid (TXA) gains increasing popularity<sup>1</sup> for reduced postoperative bleeding in patients in various fields of Plastic Surgery. It seems to be:

- A cost-effective solution for bleeding-related complications
- Significantly reduces
  - Perioperative blood loss
  - Postoperative hematoma and seroma formation
  - Drainage duration
  - Need for blood transfusions
  - Costs
  - Recovery time

However, there is a lack of standards in Plastic Surgery regarding indication, application method and dosage.

ESPRAS Executive committee has decided to prepare an European overview on this issue with an online questionnaire so to gain insight on the current status in Europe and to prepare a consensus statement on this issue possibly on our Meeting “ESPRAS – A day in Paris” in November 22<sup>nd</sup> 2024 in Paris France.
